

## **Rules and Regulations**

PARTICIPATION IN Emerging Designer Competition: East IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW. NO PURCHASE NECESSARY TO ENTER OR WIN. The Emerging Designer Competition: East is open to residents of Alabama, Connecticut, Delaware, District of Columbia, Florida, Georgia, Kentucky, Maine, Maryland, Massachusetts, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Rhode Island, South Carolina, Tennessee, Vermont, Virginia, and West Virginia. Entrants must be 18 years of age or older or have parental/guardian permission to apply. Entrants may be individual designers or teams of designers working together. Emerging Designer Competition: East is owned & produced by Charleston Fashion Week<sup>®</sup>, LLC, a subsidiary of DEZ Inc dba GulfStream Communications.

**ELIGIBILITY:** By participating, Entrants agree to be bound by these Official Rules and Regulations and the decisions of Charleston Fashion Week<sup>®</sup> which are final and binding on matters relating to Emerging Designer Competition: East.

**TERMS OF ENTRY:** By entering, you represent and warrant that your Entry consists of original works by you and/or your design team and that you have not copied or used other works to create your Entry without permission or right to do so; no person, other than Entrant has any right, title, or interest in any part of your Entry; your Entry, the use thereof by Emerging Designer Competition: East, or the exercise by Emerging Designer Competition: East of any rights granted by you pursuant to these Official Rules and Regulations and your choice to enter and compete in the Emerging Designer Competition: East, does not and will not infringe or violate any rights of any third party or entity, including, without limitation, copyright and trademark or contractual rights; you have all the rights, licenses, permissions and consents necessary to submit the Entry and to grant all of the rights that you have granted to Emerging Designer Competition: East pursuant to these Official Rules and Regulations and necessary to submit your entry in accordance with these Rules and Regulations. Entries must comply with all laws, rules, and regulations.

**HOW TO ENTER:** Entrants must register by completing the official online entry form at <a href="http://charlestonfashionweek.com/designers">http://charlestonfashionweek.com/designers</a> and submitting the application processing fee. Entrants must upload minimum of 6 photographs of Entrant's own original work ("Designs") in JPG format (the "Image"), and complete all required registration fields as designated by an asterisk (\*) on the entry submission page, hereafter collectively referred to as "Entry" or "Entries". For participant's Entry to be valid and in order for their Entry to be eligible for

voting, participant must acknowledge reading, accepting, and agreeing to the terms and conditions set forth in these Official Rules and Regulations. Entries must be received no later than 11:59 p.m. (EST) on Monday, October 17, 2016. Emerging Designer Competition: East is not responsible for any charges incurred in conjunction with the submission of Entries. All Entries submitted must be original, truthful, unpublished and without copyright restrictions. All Entries become the unrestricted property of Charleston Fashion Week<sup>®</sup>, LLC and Dez Inc. dba GulfStream Communications.

**ORIGINALITY:** Your Entry must be your original work and must not contain any third-party content or other materials (such as writing, poetry, text, graphics, artwork or logos), or any inappropriate or offensive materials.

Emerging Designer Competition: East reserves the sole and exclusive right and discretion to determine eligibility, appropriateness and fitness of Entries.

**SELECTION OF SEMIFINALISTS:** Semifinalists are selected via a juried selection process conducted by a panel of fashion industry experts. The sixteen (16) – twenty (20) Entrants with the top judge rankings will be selected as the Top Design Semifinalists and invited to compete at Emerging Designer Competition: East at Charleston Fashion Week® on Tuesday, March 14, 2017 – Friday, March 17, 2017. Four-five Semifinalists will show each night, final schedule to be determined by Charleston Fashion Week<sup>®</sup>. Judges will then select one (1) Finalist from each night's group, along with one additional Judge's Choice, to move on and compete for the Grand Prize on Saturday, March 18, 2017. A Grand Prize Winner will be selected via the fashion panel of judges at their sole discretion and be awarded as the Emerging Designer Competition: East Winner. In addition, all sixteen (16) – twenty (20) Semifinalists will be posted at http://charlestonfashionweek.com/designers for online voting for a People's Choice Award. If there is a tie in voting (if two individuals receive an equal number of online votes), the individual to be declared the People's Choice Winner will be selected by Emerging Designer Competition: East at their sole discretion. The process to select the People's Choice Winner may be modified or amended without notice at any time and is at the sole discretion of Emerging Designer Competition: East. Emerging Designer Competition: East is not responsible for technical malfunctions, outages or any other disruptions to the electronic voting process. Emerging Designer Competition: East makes no representation or warranty as to the accuracy, functionality or operation of the Emerging Designer Competition: East online voting process.

**NOTIFICATION OF SEMIFINALISTS:** Semifinalists will be notified by phone and/or email. Emerging Designer Competition: East will make three (3) attempts to contact Semifinalists at the phone number or email address provided with their Entry by December 2, 2016. If Emerging Designer Competition: East is unable to reach a Semifinalist via phone or email within 2 days, they will be disqualified and the Entrant with the next highest ranking will be selected.

**SEMIFINALIST REQUIREMENTS:** Semifinalists must commit to the following dates, in order to participate in the Competition: attend the mandatory model fitting and video filming January 20 – 23, 2017 (details below); attend the actual Lexus Charleston Fashion Week<sup>®</sup> event Tuesday, March 14 through Saturday, March 18, 2017; be on hand for final model fittings beginning at 8am on Sunday, March 12, 2017.

Semifinalists will need to arrive in Charleston on Friday, January 20, 2017, model fittings and video filming will take place on January 21 and 22<sup>nd</sup>, final schedule to be determined and at the sole discretion of Charleston Fashion Week<sup>®</sup>. Semifinalists will be responsible for their

own travel costs to and from Charleston, in addition to hotel accommodations for that weekend. CFW to provide details on preferred hotel rate.

CFW to provide hotel accommodations for out-of-town designers week of the event on the evenings of Sunday, March 12 – Saturday, March 18, 2017. All Semifinalists will be responsible for all other expenses for the week including and not limited to travel. \*Any guest(s) of the semifinalist are responsible for their own lodging and transportation and other expenses. An exception will be made for designers under the age of 18.

QUALIFICATIONS OF SEMIFINALISTS: To qualify as a Semifinalist and compete for the Grand Prize, each Semifinalist must be able to present twelve (12) looks on the runway at the Emerging Designer Competition: East (the "Collection"). Each Entrant's Collection must focus on Fall 2017, Swimwear/Resortwear 2018, and consist of original creations designed by the designer or design team as registered and uploaded to Emerging Designer Competition: East. All looks in the Collection must make their runway debut at Emerging Designer Competition: East.

Each Semifinalist will be expected to show eight (8) looks from the Collection on their runway night. If selected as a Finalist, they will then show their entire Collection (all 12 looks) on Saturday, March 18, 2017. Semifinalists are responsible for all costs and arrangements associated with the timely transportation of their Collections to Charleston Fashion Week<sup>®</sup>. Neither Emerging Designer Competition: East, Charleston Fashion Week<sup>®</sup>, Dez Inc. nor its sponsors, partners, employees, interns or any other person or entity working under the direction of Emerging Designer Competition: East are responsible for any loss or damage to Entrants' Collections.

**SEMIFINALISTS' PRIZE:** Qualifying Semifinalists will receive a runway show at Emerging Designer Competition: East during Lexus Charleston Fashion Week® on the nights of Tuesday, March 14, 2017 – Friday, March 17, 2017. Four -five Semifinalists will show each night, final schedule to be determined by Charleston Fashion Week<sup>®</sup>. Emerging Designer Competition: East will provide between eight (8) and twelve (12) models, hair, makeup, dressers, backstage crews, and all runway production needs. Semifinalists will be required to communicate their runway show artistic direction to the Emerging Designer Competition: East/Charleston Fashion Week® production team, including, but not limited to: hair, makeup, model selection and music. Failure to meet Emerging Designer Competition: East production deadlines are grounds for elimination. Semifinalists eliminated from the competition will be replaced by the Entrant with the next highest ranking. If based outside the Charleston area, Semifinalists will receive complimentary lodging for the evenings of Sunday, March 12, 2017 – Saturday, March 18, 2017. Complimentary lodging provided to Emerging Designer Competition: East Semifinalists are non-transferrable and may not be exchanged for cash value. All Semifinalists will be responsible for all other expenses for the week including and not limited to travel.

Each Semifinalist will receive two (2) tickets to their evening's runway show and two (2) tickets to Saturday evening's Fashion Finale. If selected as a Finalist, you will receive a total of four (4) tickets to Saturday evening Fashion Finale. In addition, each semifinalist will receive one (1) ticket for each night they are not showing. If you are a design duo team, you will still receive only two tickets for the night you show and two tickets if selected as a

finalist to show on Saturday; each designer of the duo will receive one (1) ticket per designer for each night they are not showing. Tickets are non-transferrable and may not be exchanged for cash value. Each Semifinalist is responsible for their own transportation to Lexus Charleston Fashion Week<sup>®</sup>.

**SELECTION OF GRAND PRIZE WINNER:** A panel of judges selected by Emerging Designer Competition: East will select one (1) Grand Prize Winner based on a review of their collection during the Emerging Designer Competition: East runway show. Emerging Designer Competition: East judges have the sole authority and discretion to select the Grand Prize Winner. The decision of the judges is final and not subject to challenge or appeal. If winner already has an existing website, F22 Designs can provide design consultation, create e-commerce component for site, dynamic photo gallery, content management system, email marketing system, contact management and more instead of full site design;
- Mentoring opportunity with fashion industry leaders while in Charleston for CFW;
- Private lunch with Fern Mallis, lead CFW Fashion Panel judge, in New York City
  if a mutually agreeable time can be arranged. Lunch to be scheduled within six (6)
  months of the competition and subject to approval by Fern Mallis under good faith
  effort. CFW to help coordinate and to pay for lunch. All expenses other than
  luncheon to be paid by Grand Prize Winner;

- Internship opportunity with a designer during New York Fashion Week in Fall 2017;
- Display of collection at In Support Of retail store in New York City with corresponding party. Exact timing and details to be determined at a later date in conjunction with In Support Of, Charleston Fashion Week® and winning designer;
- Signature jewelry piece.
